Summit session take a-ways

- Lack of understanding of SIDS verses <u>preventable</u> accidental/suffocation/ strangulation deaths
- Sleep related deaths do not discriminate
- Many deaths occur in an environment/area that could have been safe but wasn't
- This is a public health issue

Need for:

- <u>one</u> unified SC Safe Sleep message/standardized materials
- standardization on implementation of SC DHEC safe sleep video/brochure in health care systems/agencies
- SC data on sleep related injuries
- Inclusion of safe sleep in prenatal and post partum period
- Standardized safe sleep training of trainers
