SUBJECT: Rehabilitative Behavioral Health Services (RBHS) Workshop

The South Carolina Department of Health and Human Services (SCDHHS) will offer workshops in Charleston, Columbia, Florence, and Greenville to provide an overview of program specific policies and procedures, procedure codes, and reimbursement requirements for Rehabilitative Behavioral Health Services (RBHS).

Upon completion of the overview, the provider will be able to identify definitions, provider qualifications, Medicaid beneficiary eligibility requirements, covered services under RBHS, documentation required for reimbursement, and reimbursement rates. Providers are encouraged to attend to ensure correct reimbursement for claims and to avoid Medicaid Program Integrity findings and payment disallowances.

The intended audience includes current Medicaid providers of Wrap Around Services, enrolled Medicaid providers of Children's Behavioral Health Services, Child Placing State Agencies, and potential Medicaid providers of Rehabilitative Behavioral Health Services.

The workshops will be divided into two sessions on each day the training is offered.

- The morning sessions will cover RBHS policy. Morning registration will begin at 9:00AM and end at 9:30AM.
- The afternoon sessions will focus on RBHS reimbursement. Afternoon registration will begin at 1:00PM and end at 1:30PM.
