On May 17, 2011, the South Carolina Department of Health and Human Services (SCDHHS) issued a bulletin announcing our partnership with MedSolutions for the management of Prior Authorizations (PA) on High Tech Radiology Services. In order to provide clarification on this program to the provider community, MedSolutions will be offering additional provider trainings on Tuesday, September 13th and Thursday, September 15th 2011.

I. Webinar Training Schedule for High Tech Radiology Services

SCDHHS and MedSolutions will be providing webinar trainings for providers on the PA process on the following dates and times:

To attend one of the webinar sessions listed above, providers must access the appropriate webex link to login. Please note that this process may take several minutes. Providers should allow adequate time prior to the scheduled start time for registration. To join any of the sessions listed above, follow these instructions:

Pre-Registration Information (should be performed prior to the date of the webex):

1. Access the MedSolutions webex page at <http://medsolutions.webex.com>
2. Enter SCDHHS in the upper search box and click on the SEARCH button.
3. Select the training that you wish to join by clicking on the Register link for the desired session (note that times on the webex screen are displayed in Central Time). The trainings are all listed as SCDHHS Provider Orientation.
4. Enter your First Name, Last Name and Email Address and select the Register Button. You will receive an email with your login and password for the session.

Accessing the Webex:

1. Select the appropriate training time and click on the SCDHHS provider Orientation link for that session.
2. Enter the Registration ID and password supplied to you in the email (step #4 above). Click the JOIN NOW button and follow the instructions that appear on your screen.
