Medicaid Basics is an overview of South Carolina Medicaid that includes an overview of information about eligibility, claim filing options, the remittance package, Third Party Liability, and Claim-level adjustments.

The **Comprehensive Web Tool** workshop covers all features available on the South Carolina Medicaid Web-based Claims Submission Tool, an online application for sending electronic claims in HIPAA compliant format to South Carolina Medicaid.

The **Overview of Third Party Liability** workshop provides a comprehensive overview of TPL in areas including reporting responsibilities, refund process, claim adjudication, edit resolution, and other resource information.

Overview of Claim-level Adjustments is designed for Professional, Dental, and Ambulance providers. The workshop describes the detail-level process that gives providers the capability of submitting claim-level adjustments directly to South Carolina Medicaid.
