Seniors seeking opportunities to maintain active lifestyles find such a resource within the MCDC's dynamic Senior Program. The program provides a supportive, caring environment where participants develop a sense of camaraderie and engage in activities that interest them three days a week. Activities include general health information sessions, tours, crafts, and technology classes. Seniors also participate in the Silver Sneakers Program, a health and wellness initiative emphasizing exercise and nutrition. All services, including transportation and meals, will be free for all participants. Additionally, we provide weekly meals to homebound seniors who cannot participate in in-person programming.
