TO: SC Drug Alcohol and Other Drug Abuse Services (SCDAODAS) Providers

SUBJECT: Update the Psychotherapy Frequency Limits in the Rehabilitative Behavioral Health Services (RBHS) manual in the Drug and Alcohol section

The South Carolina Department of Health and Human Services (SCDHHS), Division of Behavioral Health will update the psychotherapy frequency limits in the Drug Alcohol and Other Drug Abuse Services (DAODAS) section of the Rehabilitative Behavioral Health Services (RBHS) manual as of December 1, 2014. The psychotherapy frequency limits in the DAODAS section will be the same as the rest of the manual. The changes will be reflected in section two and four of the manual. The change will only affect the fee for service claims.

If a Healthy Connections Medicaid member is enrolled with one of the state's contracted MCOs, DAODAS must receive prior approval and claim reimbursement directly from the member's MCO for services covered under the managed care service package. Procedure Code Description	Procedure Code	New Frequency Limits
Individual Psychotherapy (IT)	90832	Encounter - 30 minutes 1 per date of service IT can be rendered in a variety of combinations - 6 sessions per month
Individual Psychotherapy (IT)	90834	Encounter – up to 60 minutes 1 per date of service IT can be rendered in a variety of combinations - 6 sessions per month

Individual Psychotherapy (IT)	90837	Encounter – 60 minutes or more (e.g. 75 or 90 minutes) 1 per date of service IT can be rendered in a variety of combinations - 6 sessions per month
Individual Psychotherapy (IT) When providing Medical Evaluation and Management	90833 With the add on code 99203 or 99213	Encounter - 30 minutes 1 per date of service
Individual Psychotherapy (IT) When providing Medical Evaluation and Management	90836 With the add on code 99203 or 99213	Encounter - 45 minutes 1 per date of service
Family Psychotherapy (without Patient present)	90846	Encounter - 60 minutes 1 per date of service 4 sessions per month
Family Psychotherapy (with Patient present)	90847	Encounter - 60 minutes 1 per date of service 4 sessions per month
Multiple Family Group Psychotherapy	90849	Encounter - 60 minutes 1 per date of service 8 sessions per month
Group Psychotherapy	90853	Encounter - 60 minutes 1 per date of service 8 sessions per month
