<u>Public Notice of Final Action for the Addition of Intensive in-home Services Using the Homebuilders®</u> Model

The South Carolina Department of Health and Human Services (SCDHHS) gives notice of the following action regarding the addition of Homebuilders®, an evidence-based, intensive in-home service under the State Plan under Title XIX of the Social Security Act Medical Assistance Program (Medicaid).

Effective on or after July 1, 2024, SCDHHS will add an additional evidence-based practice for children and adolescents, Homebuilders®, to the South Carolina Medicaid State Plan. Homebuilders® is a well-documented intensive family preservation service. The following per diem rate will apply:

SCDHHS is making this change to support access to behavioral health services, enhance the state's provider network, and ensure services are delivered effectively.

Based on the actions above, SCDHHS projects a budget impact of approximately \$271,000 (total dollars) per year.
