Please explain how these funds will be used to provide a public benefit:

The work of the Grace Impact Development Center is to serve vulnerable communities in Berkeley County. These funds will be used to accomplish this in the following ways: 1) The Mobile Welding Workforce Development Program will utilize our partnership with retired master welders and a welding inspector to take training opportunities into communities where barriers exist to attend current programs. This will allow residents to take advantage of the many open welding job opportunities in Berkeley County with the help of some of our partners who will provide soft skill training, resume building and possibly transportation. 2) The Micro Learning Center is a web-based app that was created to extend many of our community center based programs into rural areas electronically via partnerships with churches and other community based organizations. These funds will support programming and further app additions and partnership building to increase the reach of our resources into rural Berkeley County. 3) Our organization has been in existence for five years (in operation for four years) and although we have had our financials and yearly tax returns prepared by an external accounting firm, we have not been able to afford an official initial audit. With this audit, we will continue to be positioned for larger capacity and programming grants from government, public and private grantors. 4) Our Harvesting Hope Food Pantry currently provides food distribution twice per month to over 100 households. These community members heavily rely on the food pantry to supplement their food security. 5) The marketing and resource development will help our nonprofit capture and effectively share the work we do and our stories. We are so busy doing the work, that we are missing this critical piece that can help us develop more consistent funding for our operations. This will in turn allow our nonprofit to provide more resources for all communities connected to our work.
