SUBJECT: Individuals with Disabilities Education Act Part C Program (BabyNet)

Updates

The South Carolina Department of Health and Human Services' (SCDHHS) will begin distributing weekly alerts to Healthy Connections Medicaid and Individuals with Disabilities Education Act (IDEA) Part C program, commonly known as "BabyNet," providers as SCDHHS carries out the integration of Healthy Connections Medicaid and IDEA Part C services. The alerts will be distributed on Tuesdays and include resources available to providers and stakeholders. Entering High Quality Service Logs Webinar

SCDHHS held a training webinar geared toward service coordination providers that focused on common errors and issues that arise when entering service logs and provided information on support available to address those issues on July 9 and 12. Updates in BRIDGES

As part of the integration of BabyNet and Healthy Connections Medicaid services, BabyNet service coordinators may see changes to information in some areas of the BabyNet Reporting & Intervention Data Gathering Electronic System (BRIDGES). This includes, but is not limited to, demographic information; third-party liability (private insurance) information; managed care organization (MCO) information; and Medicaid identification (ID) number, and associated eligibility and referral dates. No action is required on the part of service coordinators as a result of these changes. Medicaid eligibility that appears in BRIDGES should continue to be validated utilizing the Medicaid Management Information System (MMIS) web tool. SCDHHS issued an alert about the changes July 12, which is available on SCDHHS' website.
