The following questions were asked.

- 1. Will the members receive notification if a plan is no longer available?
 - The agency responded yes; the members will receive notification. The managed care plan will be placed on an action plan to review with a specified number of days to complete it.
- 2. If a plan is no longer certified, will there be a requirement of the managed care organization (MCO) regarding claims and who is responsible once they are out of market?
 - a. The agency stated each MCO contract has a transition plan component to it. This plan details the responsibilities of the MCO in the case of a termination.
- 3. Can you please look at the amount of time it takes to credential a new provider?
 - a. Credentialing time is one of the performance assessments included in the new MCO certification process, which also includes network and claims payment evaluations.
