Please explain how these funds will be used to provide a public benefit:

It is well documented that a healthy pregnancy is one of the best ways to promote a healthy birth. Getting early and regular prenatal care improves the chances of a healthy pregnancy and can help prevent complications. Prenatal care provides women with important information on nurturing and protecting their infants, monitors existing health conditions and identifies health problems that may arise during the pregnancy with a goal toward healthy moms and healthy babies. These funds will be used to provide prenatal medical care to uninsured and unserved women in a safe, welcoming and confidential setting. Services include pregnancy testing, ultrasounds, prenatal vitamins, testing for sexually transmitted infections, pap smears, counseling, individual and group classes, support groups and essential baby items. Mothers who do not get prenatal care or wait to get prenatal care until late in their pregnancy are almost three times more likely to deliver babies with low birth weights and other health issues. According to SC DHEC: PHSIS-Division of Biostatistics newborns with low birth weights are five times more likely to have serious health issues and protracted neonatal hospital stays. Pregnant women, their babies, families and the community benefit when moms and babies are given the opportunity to be healthy and well.
