

PUBLIC NOTICE

DEPARTMENT OF HEALTH AND HUMAN SERVICES

The South Carolina Department of Health and Human Services (SCDHHS) gives notice of the following proposed actions pursuant to the requirements of Title 42 CFR 435.118 regarding eligibility changes to the Children's Health Insurance Program (CHIP), implemented in accordance with The Patient Protection and Affordable Care Act of 2010 (ACA).

Effective on or after January 1, 2014, SCDHHS proposes to amend the South Carolina State Plan for Medical Assistance, to be in compliance with federally mandated reforms that support South Carolina's healthcare initiatives aimed at improving health and health outcomes.

The ACA mandates the use of Modified Adjusted Gross Income (MAGI) methodology for eligibility determination for certain groups of Medicaid applicants and beneficiaries. Existing Medicaid Children's Health Insurance Programs must convert their existing income standards (Medicaid CHIP Federal Poverty Levels (FPL)) to MAGI-equivalent standards. Effective January 1, 2014, the minimum qualifying income level for Medicaid is increased to 133% FPL for children ages 6 up to 19, making 133% FPL the minimum income level for all children under 19. South Carolina must submit a state plan amendment to reflect revised income standards to be in compliance with this requirement. States may continue to receive Title XXI funding for children transitioning to Medicaid and also receive Title XXI funding for children newly eligible for Medicaid as a result of this requirement. All other Medicaid rules under the state's Medicaid plan apply.

The following table reflects these changes:

Category	2013 FPL Limit	2014 FPL Limit
Children	200%	208%
Children 0-1	185%	194%
Children 1-5	133%	143%
Children 6-18	100%	133%

The Children's Health Insurance Program provides coverage for eligible, uninsured children whose household income is between the FPL for their age and 208%.

Proposed Budget Impact: CMS anticipates that the MAGI methodology and converted income limits will be cost neutral.
