PUBLIC NOTICE

Public Notice of Final Action for Personal Care Rate Increase

The South Carolina Department of Health and Human Services (SCDHHS) gives notice of the following action regarding rates for children’s personal care services under the State Plan under Title XIX of the Social Security Act Medical Assistance Program (Medicaid).

Effective for services on or after Jan. 1, 2023, SCDHHS will amend the South Carolina Title XIX State Plan to increase rates for the following services:

Description	Code	Current Rate	New Rate
Children’s Personal Care	T1019	\$19.40/hr.	\$25.00/hr.

The rate increase is being made to enhance the network of providers rendering services to members enrolled in the South Carolina Healthy Connections Medicaid program.

Based on the action above, SCDHHS anticipates a budget impact of approximately \$20.3 million for children’s personal care per year in total dollars.
