Incontinence Supplies Guidance Update

Healthy Connections Prime has recently updated its <u>guidance document for incontinence supplies</u>. The purpose of this guidance is to provide more clarity for those involved in the incontinence supplies management process for our members receiving incontinence supplies already and for those with an application submitted for incontinence supplies. The Appendix contains tips for waiver case managers and Healthy Connections Prime Medicare-Medicaid Plans (MMPs) and also provides sample notices that MMPs would send to waiver case managers and incontinence supplies providers.

Identifying Claims Contacts

The South Carolina Department of Health and Human Services (SCDHHS) would like to remind providers that they can use SCDHHS' eligibility verification system (WebTool) to check on their patients' enrollment into Healthy Connections Prime. This portal makes it easier to identify whether a member is enrolled in an MMP or a Medicaid managed care organization (MCO). 
