## o **Enrollment**

# SSIP (State Systemic Improvement Plan)

- Phase 3 will be submitted in April 2020.
- Stakeholder meeting will be held in a couple of weeks to get feedback from the participants of the first RBI (Routines Based Interview) training. The second training will be held soon.

# O BRIDGES Integration:

- IFSP Regeneration
  - A new list of service codes was implemented in October 2019 and IFSP's had to be regenerated to reflect the new codes. Approximately 7,000 plus IFSP's were regenerated.
  - Payment of claims is live with some manual work still being done.
  - ➤ DHHS is focusing on sending out bulletins/alerts with more targeted information.

#### Billing

- Providers are still required to put notes in BRIDGES, then the system will adjudicate the
  claim and the claim will go out of BRIDGES to MMIS and adjudicate. Providers bill
  MCO's directly. TEFRA goes through BRIDGES. Providers should not be billing through
  the web tool. They need to put notes in BRIDGES for payment to adjudicate. The
  purpose of the BRIDGES Integration is so that everyone providing service to a child can
  have access to all information for that child.
- Stephanie Hicklin is working on a narrated power point presentation to address the confusion on how claims are billed through BRIDGES.
- Interim payment process will be decommissioned and then providers will be paid for small minute roll-up.

#### Policies and Procedures

- All policies and procedures are posted except for Dispute Resolution. BabyNet will be using the internal system that DHHS already uses for Dispute Resolution.
- BabyNet will be conducting a training on policies and procedures and will continue adding job aides and other resources to the policy and procedure manual.

#### General Supervision

 BabyNet issued the first findings of non-compliance to OSEP on October 1, 2019. Lenora Burke's region presented no findings and the other regions are working on correcting their findings.
