

Distinct Patient Count for In-office Sedation (D9222) by Provider Specialty Ages 0-5





Distinct Patient Count for In-office Sedation (D9222) by Provider Specialty Ages 6-20






Distinct Patient Count for In-office Sedation (D9222) by Provider Specialty Ages 21+






Total Distinct Patient Count for In-office Sedation (D9222) by Provider Specialty





Distinct Patient Count for Facility Use (D9420) by Provider Specialty Ages 0-5








Distinct Patient Count for Facility Use (D9420) by Provider Specialty Ages 6-20



Distinct Patient Count for Facility Use (D9420) by Provider Specialty Ages 21+








Total Distinct Patient Count for Facility Use (D9420) by Provider Specialty








ASC / OP Utilization
