## Please explain how these funds will be used to provide a public benefit:

Our target population of homeowners, because of their limited finances, and they have housing issues that differ from those in moderate-income and high-income brackets. This typically leads them into difficult decision-making situations, such as the choice between/among the upkeep of their dwellings, the paying for utilities and other monthly bills or the making of essential purchases such as food, clothing, and medications. Understandably, home maintenance is frequently neglected or is at best piecemeal and reactionary. And yet, ironically, the poor condition of housing can be a key contributor to the poor health of the occupant, leading to ever higher healthcare costs and other needs. For example, it is leaking roofs and black mold on walls and floors that have precipitated or aggravated severe respiratory issues amoung many. Your awarding of these funds will enable us to aid the needy in addressing at least some of these more critical needs. We estimate that the number of roofs to be replaired and/or replaced, windows and HVAC units replaced at 15 to 20 clients. These numbers are recognized as tentative based on the issues that may be discovered upon our repair or demolition of existing damage. Also cautionary is the costs of the supplies and equipment needed for construction. We firmly believe that all our citizens need and deserve safe, secure, and sanitary housing; therefore, we are conscientious in providing excellent work and craftmanship as our service. The Marion County Long Term Recovery Group has a General Constructor who is responsible for the securing of the best qualified sub-contractors, while ensuring that accepted quotes are in line with the market, and utilizing standard and tools that comply with or exceed other state and federal funding.
