## **PUBLIC NOTICE**

# <u>Public Notice of Proposed Action for FFY 2025 DSH Payments and Updated Swing Bed Hospital</u> and Administrative Day Rates Effective Oct. 1, 2024

The South Carolina Department of Health and Human Services (SCDHHS), pursuant to the requirements of Section 1902(a)(13)(A) of the Social Security Act, gives notice of the following proposed actions regarding its methods and standards for establishing Medicaid Disproportionate Share Hospital (DSH) payments to qualifying DSH hospitals and updating swing bed hospital and administrative day rates.

Pending new federal legislation, implementation of the DSH Patient Protection and Affordable Care Act (ACA) reductions are to occur from federal fiscal year (FFY) 2025 (specifically, the period beginning Jan. 1, 2025, and ending Sept. 30, 2025) through FFY 2027. The aggregate DSH reductions to the Medicaid DSH allotments equal \$8 billion for each of those years.

#### Proposed DSH Changes Effective for the Oct. 1, 2024–Sept. 30, 2025, Payment Period

- The agency proposes to use the hospital fiscal year ending 2023 base year cost reporting period to calculate the interim DSH payments for the Oct. 1, 2024—Sept. 30, 2025, DSH payment period. The agency will continue to use the Dec. 19, 2008, final rule (Federal Register/Vol. 73, No. 245) relating to the audits of the Medicaid DSH payment plans and the Dec. 3, 2014, final rule (Federal Register/Vol. 79, No. 232) relating to the Medicaid program DSH payments uninsured definition.
- The agency proposes to update the inflation rate used to trend the DSH base year cost to the end of the 2023 calendar year.
- The Centers for Medicare and Medicaid Services (CMS) has approved the state-directed payment for Health Access, Workforce and Quality (HAWQ) program. As a result of this approval, the agency does not anticipate expending 100% of its FFY 2025 Medicaid DSH allotment to qualifying DSH-eligible hospitals during the Medicaid State Plan rate year.

### Proposed Inpatient Hospital Reimbursement Changes Effective Oct. 1, 2024

• The agency proposes to update the inpatient hospital swing bed and administrative day rates based on the Oct. 1, 2024, redetermination of nursing facility payment rates.

For DSH changes, SCDHHS proposes to implement bullets one through three to calculate the FFY 2025 DSH payments based on the use of the most recent cost reporting period data available (hospital fiscal year 2023) and updated DSH allotment amounts.

For inpatient hospital changes, SCDHHS proposes to update the swing bed and administrative day rates effective Oct. 1, 2024, based on the redetermination of nursing facility payment rates effective Oct. 1, 2024.

As a result of the proposed actions listed above, the annual projected cost increases, in total dollars, are approximately \$10 million for DSH payments and an immaterial increase, less than \$10,000, for swing bed/administrative day rates.
