

#### **SCDHHS COVID-19 Resources**

  - New provider alert sent out Jan. 22, 2021:
    - Appendix K flexibilities extended to no later than six months after the expiration of the public health emergency, unless determined to end earlier







- Centers for Medicare and Medicaid Services (CMS) revised deadlines for the heightened scrutiny process:
  - Category 2 settings (next to or on the grounds of a public institution) must be submitted to CMS no later than March 31, 2021
  - Category 3 settings (has the effect of isolating individuals):
    - ➤ If the setting can be remediated by July 1, 2021, it's not submitted to CMS for heightened scrutiny review but still must be publicly listed
    - ➤ If the setting can be remediated, but not until after July 1, 2021, it must be submitted to CMS by Oct. 31, 2021



- Category 2 settings timeline:
  - Providers submit evidence packages to SCDDSN:
    - > Oct. 30, 2020
  - Revised public notice and comment period:
    - > Feb. 10 March 12, 2021
    - General webinar: Feb. 17, 2021
      - ▶ 11:30 a.m. 1:00 p.m.
      - Information to register on the SCDHHS HCBS website (2)
    - Public notice will be released on Feb. 10, 2021
  - Revised submission date to CMS:
    - March 31, 2021



- Category 3 settings timeline:
  - Providers submit evidence packages to SCDDSN:
    - > Nov. 30, 2020
  - Public notice and comment period:
    - > Aug. 3, 2021 Oct. 1, 2021
  - Submission date to CMS:
    - > Oct. 29, 2021
