Statewide Transition Plan (STP)

- STP submitted to Centers for Medicare and Medicaid Services (CMS) for final approval consideration
 - Submitted to CMS by Oct. 11, 2019
 - Two sets of technical changes made
- Final Approval granted Feb. 4, 2020
 - Final approval letter posted on SCDHHS website
 - Clean version of STP posted on website
 - Version with technical changes also posted on website




Long Term Living (LTL)

- Policy update: Adult Day Health Care (ADHC) providers:
 - SCDHHS has the authority to terminate contracts if new ADHCs are not 100% complying with the settings rule
- ADHC providers who want training specific to HCBS requirements contact:

HCBS Compliance – 2022 and Beyond

- As a reminder, CMS is clear:
 - ALL HCB settings <u>must</u> be in compliance by 2022
 - There is <u>NO remediation</u> for any non-compliant setting after that date
 - If a setting is non-compliant, the state <u>cannot claim</u> federal financial participation (FFP) for any services provided in that setting
