## Sumter Behavioral Health Services

### Funding request for 2023

#### \$250,000 Sumter Women's Residential

- Infrastructure needs to address the increased demands on our staff; the need to employ more staff than in previous fiscal years to ensure adequate coverage on all shifts.
- Increased need to maintain resources to provide appropriate and 24hr/day service to a challenging population. This program requires a large staff to help cover 24 hrs per day, 7 days per week without leaving staff alone and vulnerable.
- Nearly 50% of our admissions can be to pregnant women or those in the first year of postpartum requiring level 3.5 care.
- The Sumter Women's Residential Program is consistently threatened by the reduced reimbursement of services from MCO's and Medicaid. It is increasingly difficult to keep women longer than 21 days; at which time they are not typically ready for discharge but no longer have payment for services.
- Many women entering 3.5 level of care without their children run the risk of losing their Medicaid/MCO payer.
- These issues have been exacerbated by the COVID 19. It has caused strain on staff and clients alike.
- Increased referrals for a higher level of care for women who do not have any paying insurance. We only receive so much from DAODAS through HOP funds and easily spend that on only 2-3 admissions per year. With additional funds we would be able to help at least double. This would increase our ability to fund treatment for lower income uninsured women, pregnant women, women with dependent children, or IV drug using women who are all more at risk.
- DAODAS only funds 50% of what it costs to run the program including salary, fringe and overhead on the building.

#### \$250,000 – Adolescent Outpatient

- The Sumter County area is overwhelmed with adolescents needing services. The school district has an increase of children in need; and our referrals have doubled this fiscal year where the need for additional counselors has arisen.
- Transportation and distance to services in Sumter cause a barrier. Our agency has partnered with Sumter School District and Liberty Steam Charter to offer services at the schools. We need additional funds to support our transportation costs and to hire additional counselors so that we can offer enough services without staff becoming overwhelmed.
- This specific need is for funding to employ at least 2 additional counselors to work specifically with school aged children in and out of our local school system; including a local charter school.
- South Carolina's rate of school aged children suffering from mental health issues more than doubled in 2020; results from 2022 are not in but researcher say it has not decreased. There are not enough providers in Sumter to handle the overload of
