**Transition Referral Update-** BabyNet has added two new fields on the Transition Referral form. The updated form includes fields for race and ethnicity. Middle has also been added to the name field. The updated form is on the BabyNet website.

Note: The race categories and abbreviations are listed at the bottom of the form on page 2.

### **BabyNet Documentation and Billing**

- *Video-* BabyNet has added a presentation in SCEILS that reviews how documentation and billing data must be entered in BRIDGES in order for payments to process appropriately. The 11-minute video answers common questions for providers, billing/agency administrators, service coordinators, etc. All BRIDGES users (except BabyNet Eligibility and Foreign Language Interpreters) must review the presentation no later than November 30, 2023. It will remain active after this date for future reference and review. You will also find pdf's of the presentation within the course in SCEILS.

- *BabyNet Brief “Service Logs”*- The BabyNet Brief highlights topics in the *BabyNet Documentation and Billing* video.
- *Verifying Private Insurance Updates*- As families are participating in open enrollment this fall, we ask that beginning in November, service coordinators check with all families to determine if their private insurance policy will be changing. This could include the following: Changing carriers/policies, dropping private insurance altogether, or adding a new policy after not having one. Please be sure to send in a HIIRF to [ohi.priorities@bcssc.com](mailto:ohi.priorities@bcssc.com), in order to have policy changes recorded in BRIDGES. If corrections are not made in a timely manner, providers may not be paid correctly.

**Family Outcomes Survey Webinar** - BabyNet and TECS hosted two webinars to review the changes to the Family Outcomes Survey process. The first webinar was on October 25, 2023 and the second was held on November 17, 2023. Individuals who were not able to attend will be able to view the presentation in SCEILS.

**COS Knowledge Check**- The Child Outcomes Summary training is intended for IFSP team members, to use and determine their level of understanding and application of the COS process. The COS Knowledge Check, is located on the DaSy website and the COS Modules are located in SCEILS. When registering for the COS-KC, **please be sure to take the 0-3 assessment (not 3-5)**. Participants will have two attempts to take the COS-KC. If participants fail during both attempts, they are required to complete 6 online modules that explains the COS process in detail. The Knowledge check is REQUIRED for Early Interventionists and OPTIONAL for therapy providers. It does NOT apply to Foreign Language Interpreters. TECS sent out an email with instructions. Early Interventionists will have 6 months to complete COS-KC and/or modules. The knowledge check and modules are wonderful tools for ensuring that our child outcomes ratings and data is accurate and of high quality!

**Greenwood Genetics**- Greenwood Genetics hosted a virtual training on November 3, 2023. The training covered topics such as the Mission and Vision of Greenwood Genetics, how and when to make a referral, and what happens after the referral is made. A recording will be put in SCEILS for service coordinators who were not able to attend the virtual Training.
