07jul21 Due to the discrepancy in trends for FFY 2020 between the point-in-time count and the cumulative count for this category, South Carolina service coordination providers were required to confirm the race and ethnicity of the children included in the original submission. The data for this category has been revised to reflect the verification, and includes a small number of children (n < 20) whose race and ethnicity could not be verified due to closure of business by four service coordination provider agencies.
